

Gecić Law Steers Telekom Srbija on a Historic Deal in the Western Balkans

- Transaction Value: Combined enterprise value of €1.5 billion for the two concurrent transactions, marking a historic high for the region's telecom sector.
- Assets Acquired: Telekom Srbija will acquire Eon TV International Ltd (the holding company for the NetTV Plus platform), its direct-to-home businesses in Serbia and North Macedonia (DTH), and certain Sport Klub rights in the Western Balkans. This acquisition will enhance Telekom Srbija's digital television services and premium content portfolio.

The acquisition is part of a broader deal with a combined enterprise value of €1.5 billion, representing one of the largest telecom sector transactions in the region's history. As part of the broader transaction, e& PPF Telecom-majorityowned by e& and Czech Group PPF—will acquire SBB and integrate it with Yettel. This deal significantly bolsters Telekom Srbija's market position and expands its digital content offerings for consumers across the Western Balkans and Southeast European diaspora.
